I am aware and understand that this Event and the sport of skiing have inherent dangers, hazards, and risks (collectively called the "RISKS"). The following is only a partial list of examples of these RISKS:

Negligence of the Host; Falling at any speed; Negligence of other skiers; Equipment failure; Nature of skiing terrain; Improper use of equipment; Condition of skiing surface; Falling at high speed while racing or skiing; Failing to successfully ski any steep and bumpy terrain; Changing weather conditions and snow conditions; Possibility that certain risks may be unmarked; Collision with natural or manmade objects or other skiers or bystanders; Disabilities of my own that may increase the likelihood of occurrence of the RISKS.

I understand that injuries resulting from such RISKS can and may be a common and ordinary occurrence of the EVENT and the sport. I freely accept and fully assume all the RISKS and the possibility of personal injury, accident, death, property damage or loss resulting from being a Participant.

I, the above named and undersigned Participant (together with my heirs, next-of-kin, executors, administrators and assignees (collectively called my "LEGAL REPRESENTATIVES")) and if under the age of 21 years my parent or legal guardian, in consideration of being permitted to take part in the

I understand and agree that any payment that may be made or offered by the ORGANIZER, its officers, directors, members, employees, agents, successors, assigns, and all persons voluntarily assisting the ORGANIZER shall not be construed as an admission by these of any accidents or RISKS, and such liability is expressly denied.

I give full permission to use any photographs or movies of my participation taken during this EVENT for any purpose in promoting either this EVENT or similar EVENTS of the ORGANIZER.

If my disability prevents reading or otherwise understanding this Release I state that I have, by my own methods, had this entire Release read to me. I have, in addition to my own understanding of this Release, relied upon the advice of the Parent/Guardian signing and am able to state that by signing this Release I am waiving certain legal rights which I or, if I die, my LEGAL REPRESENTATIVES may have against the Releasees.

I acknowledge that it remains my sole responsibility to act in such a manner as to be responsible for my own safety and participate within my own limits.
